## Dr. Kelly Odden Flex PACE Approved



The JSDC Board of Directors voted to approve the Flex PACE request of up to \$85,714.30 for interest buydown for Dr. Kelly Odden at their February meeting.

Kelly Odden, DDS is purchasing 33.33% of Downtown Dental in Jamestown which includes the practice, building, equipment and customer base. Kelly provides all general dental services and is committed to serving Jamestown and the surrounding areas by helping those she serves reach and maintain optimal dental health which is a gateway to overall health. Having another committed dentist to the

practice will help to increase capacity of patients while decreasing wait times to help serve more patients.

# 201 Aesthetics Flex PACE Approved

The JSDC Board of Directors voted to approve the Flex PACE request of up to \$45,275.47 for interest buydown for 201 Aesthetics at their February meeting. This funding is contingent upon the application for their Renaissance Zone tax exemption being declined.

201 Aesthetics, owners Kalsie Gumke and Jozie

Kovar, are purchasing a building at 201 1st Ave N in Jamestown and will open a medical spa and full salon. 201 Aesthetics will be the only medical spa in a 100-mile radius. The aesthetics industry is on the rise and many individuals from the community travel to Fargo or Bismarck for services and will now be able to receive services in our city/county. Aesthetic services provided will include: injection of neuromodulators (Botox), dermal fillers, laser, skin pen (microneedling) as well as have a full service hair salon. As they grow, they hope to include massage therapy, brow and lash services and red light therapy.





# Spring 2024 Internship Reimbursement Application Approved

The JSDC Board of Directors approved one internship reimbursement application for the Spring 2024 semester at their February meeting.

JSDC matches up to half of the payroll costs per approved intern up to a maximum reimbursement of \$3,500. The program is open to employers in Stutsman County. Be on the lookout for the Summer 2024 application in the coming months!



## **Daycare Request Approved**

The JSDC Board of Directors approved one Daycare Expansion request at their February meeting. The request was for up to \$2,393.50 in match funds.

Party Crashers is expanding to afterschool care at their Discovery Zone and will open up an additional 20 to 25 childcare spots for elementary-age children. They will be using the funds to build an additional bathroom and make sure that their facility is up to code. They are scheduled to open on February 20th.
