Jamestown Monument



Jamestown Monument was loaned \$85,714 through the Flex PACE Interest Buydown Program to purchase real estate to construct a new building to facilitate the growth of their business. This expansion was aimed at increasing production, updating equipment, and providing a healthier environment for their employees.

Liechty International, LLC.

Liechty International was loaned \$85,714 through the Flex PACE Interest Buydown Program to transfer ownership to the third generation of the family. Liechty has been operating in Jamestown for many years and provides affordable modular and manufactured homes, as well as managing local mobile home sites. They also expanded to sell locally produced cabins.

BJM Premium Property Management

BJM Properties was loaned \$54,028.37 through the Flex PACE Interest Buydown Program to purchase and renovate a downtown building to house BJM and Premium Property Management, both owned by Tim and Kryston Perkins. They were in need of additional business space and were able to move from a leased space to an owned space.

Grainline Investments

Grainline Investments was loaned \$68,588.33 through the Flex PACE Interest Buydown Program to purchase and renovate the former Jamestown Sun space to create a new brewery space, Drift Prairie Brewing Company, for the community.







Joanie's Estate Sales

Joanies's Estate Sales was loaned \$35,194.55 through the Flex PACE Interest Buydown Program to help purchase a facility to expand both their services and retail/storage space.

Roemmich Daycare Project

Chad and Kaycee Roemmich were loaned \$21,036.53 through the Flex PACE Interest Buydown Program to purchase a a house for a new daycare facility. The sole purpose of the house is to run a daycare, which has opened up seventeen much needed childcare spots in the community.







Agri-Cover

Agri-Cover was loaned \$215,000 through the PACE Interest Buydown Program from the JSDC and up to \$500,000 from the Bank of North Dakota to build a new facility to house their truck tarp manufacturing.

ADLP (Applied Digital)

ADLP was loaned \$217,000 through the PACE Interest Buydown Program from the JSDC to construct a 100MW Hosting Facility.





Shocker Hitch

Shocker Hitch was loaned \$217,000 through the PACE Interest Buydown Program from the JSDC to purchase a building to house their manufacturing and shipping department.

They were also loaned \$70,680 through the New Job Training Fund. This business is bringing twenty new full time jobs to the area.



Internship Reimbursement Program

The JSDC Internship Reimbursement Program was implemented in 2021 to increase the number of local internships and assist our employers in workforce recruitment and retention. The Program contributes up to \$3,500 to reimburse employers who hire university/college students.

Internship Reimbursement Program

The JSDC helped fund a total of ten interns across nine different workplaces in the Jamestown/Stutsman County area throughout 2022.

Community Development Award

Jamestown Monument

Jamestown Monument is a family run business of over forty years that prides itself on personalized service to its clientele. They are a full service monument company offering memorials and monuments of all types. They provide installation services, resetting and refinishing of existing memorials, and cemetery lettering service throughout the area. All of their memorials are designed and made on-site.

With help from our Flex PACE program Jamestown Monument was able to move to a new, larger location at 2509 3rd Ave SW. Their goal with their expansion was to be able to increase the number of memorials that they can deliver to local cemeteries and also increase the rate at which they are completed. Their new location helps this growing business by adding space for larger work areas, the addition of new employees, and it is also equipped with updated dust collection to provide a safer work space for employees.

Growing Jamestown Award



When choosing a business to receive this award, JSDC looks at two specific criteria: the business must be currently working with JSDC or have done so in the past, and the business must have a positive influence on our local economy.

Green Bison Soy Processing

In 2021, ADM announced their \$350 million plan to build North Dakota's first-ever dedicated soybean crushing plant and refinery to meet fastgrowing demand from food, feed, industrial and biofuel customers, including producers of renewable diesel, in Spiritwood, ND. Bringing this fantastic project to our area involved years of collaboration among many entities as indicated in Governor Burgum's statement, "We're deeply grateful for ADM's investment in our state and our highly productive farmers as well as the tireless efforts of so many who helped make this happen, including the Office of State Tax Commissioner, the Jamestown/Stutsman County Development Corp., North Dakota Department of Commerce, North Dakota Department of Agriculture, Lt. Gov. Brent Sanford, the state Legislature, and our entire congressional delegation."The crush and refining complex will feature state-of-the-art automation technology and have the capacity to process 150,000 bushels of soybeans per day. Strategically located in a major soybean producing area, ADM's global logistics network will enable the facility to access both domestic and global markets for soybean oil and meal. The facility is expected to provide 75 full-time jobs and be completed prior to the 2023 harvest.

Chamber of Commerce

The Jamestown Area of Commerce started the year with the 91st Annual Chamber Awards Banquet. Nick Bruns with Nodak Insurance received the Young Professional of the Year Award, The Anne Carlsen Center received the Business of the Year, Searle Swelund received the Above & Beyond Award, and Dr. Polly Peterson was named Citizen of the Year.

The Young Professionals of Jamestown held their first ever Leadership Academy, which saw nearly 20 participants. The Young Professionals also held their annual March Meltdown Volleyball Tournament and a Cornhole Tournament during Buffalo Days in July. They also held twelve Business of the Month presentations.

The Ag Energy Committee sponsored an expert panel at the 2022 Winter Ag & Construction Expo. Moderator Mick Kjar led discussion on the ADM Soybean Crushing Plant building in Spriritwood. Panelists represented Great River Energy, Jamestown/Stutsman Development Corporation, Midwest AgEnergy, and ADM. They also hosted a Bus Tour to Cows & Co. Creamery and Dairy Farming Carrington and the Farmer's Appreciation Dinner & Dance.

The Beautification Committee helped continue their efforts of beautifying Jamestown through the Yard of the Week program. They also recognized and inspired business members of the community through their award at the Annual Banquet. Coordinated efforts with the City and Newman Signs helped maintain the new Welcome banners along Mill Hill.

The Chamber Ambassadors continued their strong support for the Chamber and it's activities. They continue to volunteer, help promote, and distribute information regarding the Chamber. They help with presence at events including ribbon cutting, Business After Hours, Business of the Month, Customer Service presentations, and more. They also helped grow the new Welcome to Jamestown program, which extends an inviting welcome to new employees and residents of Jamestown.

The Workforce Committee continued their efforts of addressing workforce challenges and helped to elevate the JSDC Internship Program. They helped spread the word to local employers about Foreign Worker Program Opportunities and provided local education work-based programs.

The Chamber held their big Buffalo Days community celebration July 22-24. The weekend long event include the big parade, Jamestown Fire Department Pancake Breakfast, mini art hunt, historic offerings at Fort Seward and the 1883 Stutsman County Courthouse, speedway races, Splash Bash at Meidinger Splash Park, and James Valley Off-roaders mud drags.

The final major event in 2022 was the Loyal to Local Passport Program. The second annual program saw an even bigger success, helping to track and keep more than \$135,000 in local spending and helped to provide a boost to the economy.

Finally, Jamestown Tourism and the Jamestown Area of Commerce entered into a shared partnership in 2022. The move came as a way to provide efficiencies to both entities and allowed them to share and Executive Director and hire a Marketing Manager to assist with marketing for both Tourism and the Chamber.

The Jamestown Area Chamber of Commerce and its committees are striving for continue growth and opportunities in 2023.

Jamestown Tourism

Jamestown Tourism and JSDC dollars continue to work together to ensure strong visitor experiences.

In 2022, dollars were utilized to increase Jamestown's digital presence online. Work with Tilladelse helped us expand our footprint online through keywords and search engine optimization. A partner project between tourism, Tilladelse, and Quantum Digital took place in the summer. Ten long-form videos were filmed and edited as a unique tool to market the area.

For the Frontier Village, summer 2022 saw the rollout of a new cast of characters designed to make the site more family friendly and help tell the tales of the buildings and help in retelling its history. Rehabilitation work also began on the General Store, which looks to be operational with merchandise, ice cream, and more for the summer of 2023.

Jamestown Tourism entered into a partnership with the Jamestown Area Chamber of Commerce as leadership roles changed. The move, approved by both entities and their boards, has allowed for streamlining costs and allotted the ability to create a marketing role for both organizations.

Tourism requested more funding for 2023 from JSDC as the demand for digital marketing grows. With the approved dollars, Tourism looks to continue its successful efforts of marketing on a bigger digital scale and reach a new audience to grow visitation in the years to come.

We greatly appreciate the strong support that JSDC has continued to offer.
