Steve informed the Board that bid opening for the Airport Business Park project opened last week. A copy of the bids was provided in the dropbox and for those present. Steve commented 3 contractors bid sections 1-4 and 2 contractors bid section 5. One bid was unopened due to the company's presidents' and attorney's signature not being notarized. The unopened bid was sent to Kelsey Krapp, JSDC's attorney to review. Kelsey was present and commented this would be considered a minor informality therefore he noted he did not see any issues. Another bid did not acknowledge their addendum therefore it was not opened. Kelsey noted failure to acknowledge the addendum would not be considered a minor informality, therefore the assessment not to open is correct. Kelsey opened the bid reviewed that was considered a minor informality and read to the group.

After a review of all bids had been completed, it was determined that the lowest bid for section 1-4 was from Border States Paving in the dollar amount of \$2,174,962.76 and from Strata Corporation for section 5 in the dollar amount of \$124,362.00.

Katie Andersen motioned to award the bid to Border States Paving for sections 1-4 in the amount of \$2,174,962.76 and Strata Corporation for section 5 in the amount of \$124,362.00, Bob Toso seconded the motion, and the motion passed unanimously.
