Charge On Together Center LLC Flex PACE Approved



The JSDC Board of Directors voted to approve the Flex PACE request of up to \$55,093.68 for interest buydown for Charge On Together Center LLC at their April meeting. This funding is contingent upon the application for their Renaissance Zone tax exemption being declined.

Charge on Together Center, LLC, owner Nicole Stevahn, purchased a building at 421 1st Ave S in Jamestown and will be opening a second location for daycare. The additional location will open 54 more spots for children ages 0-12 years and is available to provide childcare to any family as they have no restrictions on who they can provide care for. They will also be providing meals for the children.





Automate ND Grant Program Deadline is May 30th

The Automate ND Grant Program will make grants of up to \$500,000 to North Dakota Primary Sector Certified (PSC) businesses (I.e., manufacturing, ag processing, etc). The grant cannot be more than 50% of the machinery, equipment, or software being purchased.


