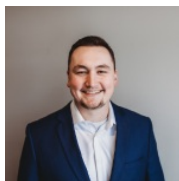

At their January meeting, the JSDC Board of Directors approved the Mid Mac Marketing PACE Request for \$214,285.74 pending approval from the City and County.

Mic Mac Marketing, Inc., owned by Keith and Casey Veil, is expanding its current location at 8171 36th St SE in Jamestown to improve efficiency, increase capacity, and begin consolidating its two locations. This marks the first phase of the expansion, with powder coating operations remaining at their Hwy 281 S site. The project aims to provide greater stability for current employees, create space for new hires, boost local property tax revenue, and enhance the company's competitiveness to support future growth.

This request will now go onto the city and county for approval.

Vetter Construction, owned by Michael and Melissa Vetter, and Kiella Lawrence Photography, owned by LaKiella Lawrence, are jointly purchasing a building at 1022 4th Avenue SW in Jamestown, with each owning a 33.33% share. This purchase will provide Vetter Construction with a storefront where customers can view products and inquire about services in person. It will also offer Kiella Lawrence Photography a larger studio space to meet client demand and the opportunity to host workshops.

JVCTC Request Approved by Board

At their January meeting, the JSDC Board of Directors approved the JVCTC Request for up to \$35,000, pending approval from the City and County

The James Valley Career and Tech Center (JVCTC) is launching a CDL program that will enhance the certifications students can earn, leading directly to employment opportunities within the community. This program aims to address a critical local need by increasing the number of qualified commercial drivers for roles ranging from agricultural services to activity buses. JVCTC students will earn both high school credit and professional certification, while the program also provides adult education opportunities through access to CDL training equipment and partner initiatives.

The requested funds will help meet the matching grant requirements of the North Dakota Department of Commerce Skills Training Grant. These funds will cover the cost of a CDL driving simulator (including annual maintenance and updates), a semi-tractor, a semi-trailer (van trailer) for transporting the simulator to other communities, and a golf cart with a small trailer for entry-level trailer training.

This request will now go onto the city and county for approval.

Tory Hart was honored with a plaque at our January Board meeting, in recognition of his two years as Chair of the Board. Thank you for your dedication to the JSDC!

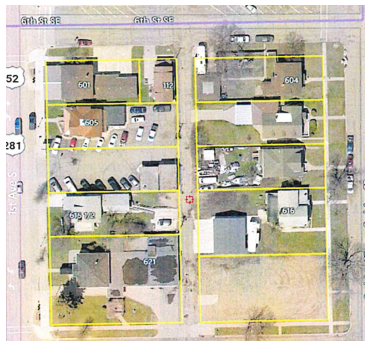

Spring Internship Reimbursement Applications Approved



The JSDC Board of Directors approved three internship reimbursement applications for the Spring 2024 semester at their January meeting. The Internship Reimbursement Program is designed to increase the number of local internships and assist employers in workforce recruitment and retention.

The Program reimburses employers up to \$3,500 for the payroll costs of university/college students hired as interns. Qualified employers must be in Stutsman County and pay the intern at least \$15/hour.

Funding Support for STEM Interns Available

The Students in Technology Transfer and Research (STTAR) program, a long-standing initiative by ND EPSCoR, bridges the gap between academia and industry. Since 1994, STTAR has provided upper-division STEM students with invaluable hands-on experience while offering North Dakota businesses innovative solutions to their technological challenges.



Businesses interested in participating gain access to a talent pool of technically skilled students ready to make significant contributions, whether by advancing product development, optimizing processes, or fostering technology transfer.

Eligible companies receive a cost-share of \$7.50 per hour toward interns' wages, with interns earning a minimum of \$15 per hour. Applications for the summer 2025 program are due by February 28, 2025.
