## Buffalo City Office Flex PACE Request Approved

The JSDC Board of Directors voted to approve the Flex PACE request of up to \$51,342.75 for interest buydown for Buffalo City Office, LLC at their November meeting.

Buffalo City Offices, LLC is purchasing a building at 312 2nd Ave SW in Jamestown to establish Center Counseling, which will offer counseling services for children seven and younger—an age group currently underserved in the community. Center Counseling is committed to supporting individuals seeking guidance and healing, with board-certified practitioners trained in clinical, evidence-based therapies.



## Nordic One Flex PACE Request Approved

The JSDC Board of Directors voted to approve the Flex PACE request of up to \$26,283.13 for interest buydown for Nordic One, LLC at their November meeting.

Bjorn Hanson, owner of Nordic One, LLC, plans to buy a building at 305 12th Ave SE in Jamestown to expand his furniture repair, refinishing, and carpentry business. His shop will serve both residential and commercial clients in the community, offering a local option for these services. The space will be equipped with woodworking tools and a spray booth.

Funding will cover the building purchase and renovations to create a dedicated space for quality counseling services.

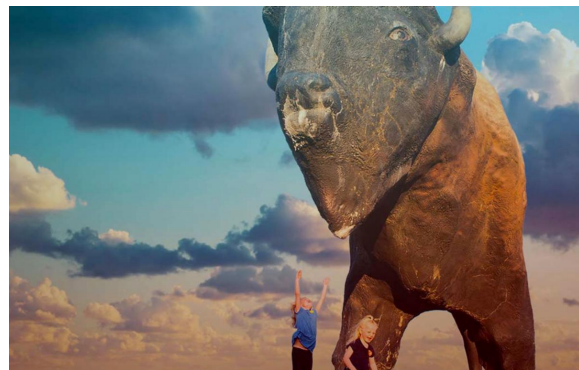

## Jamestown Tourism Request Approved

At its November meeting, the JSDC Board of Directors approved the 2025 request for \$125,000 in marketing dollars for Jamestown Tourism.

These funds directly support efforts to attract visitors to Jamestown and nearby areas. This investment will help expand on successful campaigns launched in 2024, using digital tools to reach more people and refine messaging based on visitor interests. While traditional media remains important, the tourism office has adapted to changing trends, partnering with marketing firms to create effective solutions and gather more photos and videos for engaging content. In 2024, campaigns focused on History and Culture Enthusiasts, Road Trippers, Families, and Outdoor Enthusiasts, utilizing social media and Google Display ads to drive significant website traffic. Warren has worked closely with the Chamber and City to align branding across these entities, presenting a unified and positive image of Jamestown. This





collaboration strengthens Tourism's message and highlights the growth and improvements within our community.

Participation is easy:
