Cheers to a Successful 2021

Under the leadership of Connie Ova, CEO, the Board of Directors, and the staff, JSDC closes out a very successful 2021.

JSDC approved just under \$600,000 in Flex PACE funding this year which leveraged \$1.3 million in grant funds from the Bank of North Dakota and another \$8.57 million in private investment. Collins Aerospace is the first tenant in the Jamestown Aviation Park. JSDC continues to work with other interested parties in this Park. The ADM soybean crush facility in Spiritwood, ND has been confirmed and demolition and construction is currently underway. Plans and financial analysis of the Bison World project have been completed, the Bison World Fund has been formed, and its leaders continue to move this project forward. Applied Blockchain continues a speedy build just north of Jamestown.
