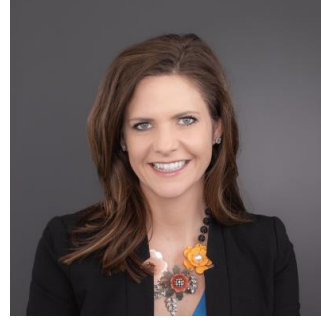
### Welcome to our New Directors
