Exciting Changes on the Horizon: Building Remodel Set to Begin in December

A remodel will soon be underway at our shared building to improve accessibility, security, and efficiency for staff and visitors. The Department of Motor Vehicles will move into the space formerly occupied by the National Guard, gaining upgraded security features and enclosed offices.



The DMV's current area will become a new visitor lobby for Jamestown Tourism, creating a more welcoming entrance for guests.

Several former National Guard and Chamber offices will be reconfigured to add more office and hallway space, and new indoor connections between the Chamber and JSDC offices will make it easier for staff to move throughout the building. These updates will modernize the facility and better serve the community while supporting collaboration among all building partners.

The JSDC Board of Directors approved \$80,000 for their share of the renovation costs at their November meeting. This will be with an 80/20 city/county split. This request will now go to the city and county for approval. Stay tuned for more updates!

Tourism Funding Approved to Continue Driving Jamestown's Visibility



At the November JSDC Board of Directors meeting, the board approved Jamestown Tourism's annual funding request of \$125,000, with costs split 80/20 between the city and county. This request will now go to the city and county for approval. The funding will continue supporting digital-first destination marketing, local partnerships, and innovative campaigns that strengthen Jamestown's presence in key markets.

During their presentation, Emily and Warren from <u>Jamestown Tourism</u> highlighted the ongoing collaboration with North Dakota Tourism to expand Jamestown's reach in major metropolitan areas, such as Chicago and Minneapolis. Digital campaigns have generated over eight million impressions and have seen a notable increase in clicks this year. Although overall website visits declined due to a platform transition and changing digital behaviors due to the rise of AI, engagement and video completion rates remained well above industry averages.

Regional tourism activity also remains strong. Frontier Village, home of the World's Largest Buffalo, welcomed about 137,000 guests this year, and overnight stays in Jamestown increased by 1.3%. Roughly 64% of tracked visitors stayed overnight, contributing to higher hospitality tax revenues and an estimated \$17 million local tourism impact.

Jamestown Tourism's creative partnerships and influencer collaborations have produced authentic, high-quality social media content that continues to boost awareness for local attractions, museums, and events. The award-winning "marketing co-op" program also helped elevate exposure for community partners throughout the region.

Looking ahead, the Tourism team also shared plans for a new multi-year content initiative and upcoming collaborations, including cross-promotions with the future Theodore Roosevelt Presidential Library.

JSDC Internship Program Evolves into Workforce Pathways Initiative

At their November Board of Directors meeting, the JSDC Board of Directors approved a series of updates to the Internship Reimbursement Program, marking a renewed focus on workforce development and long-term career outcomes. Now transitioning into the Workforce Pathways Program, the initiative aims to go beyond traditional



internships by helping students build meaningful career connections and encouraging them to stay in Jamestown and Stutsman County after graduation.

Key updates include the introduction of a new evaluation rubric and enhanced eligibility criteria for employers to ensure internships provide substantial, career-relevant experience. A major addition is the emphasis on full-time employment pathways, requiring organizations to outline how an internship could transition into a permanent role aligned with the student's field of study.

The program will also expand outreach to participating interns to better track postgraduation outcomes and strengthen data collection. Collaboration with the Young Professionals of Jamestown will help connect young talent to local business and community opportunities.

The program's core funding model remains the same. An additional funding request of \$35,000, split 80/20 between the city and county to support up to ten internships in the coming year, was approved and will now go to the city and county for approval. The new structure represents a strategic shift toward building a stronger local workforce.

Our goal is to make internships more than short-term experiences, creating real opportunities for students to build their careers and futures in the Jamestown region!
